ON FACTS


1. Correct to the extent that the Appellant was appointed as Union Council Secretary through Directorate General, Local Government, Corrigendum No. DG(RIP) 2(11)/73 dated 05.05.1998 in place of Shahid ur Rehman S/O Muhammad Zafar. As Directorate General, Local Government & Rural Development Department, Khyber Pakhtunkhwa was dissolved in 2001 and was restored in 2012 but no record was handed over back hence there is no record of the Seniority List available at this office. (Copy of Appointment Order and Corrigendum are enclosed as Annexure A & B)


2. **Incorrect.** No original record of the mentioned Seniority Lists is available at this office, hence denied.
3. **Incorrect.** No such circular has been issued by respondent No. 1.
4. **Incorrect.** Seniority List of Village Secretaries has neither been issued on 23.03.2023 nor December 2023: However, Final Seniority List of Village Secretaries was issued by Respondent No. 3 on August 30, 2021. (Copy of Final Seniority List is attached as Annexure C)
5. **Correct.** A complaint was filed by the appellant before the scrutiny committee which was decided against the appellant. (Copy of Committee Report is attached as Annexure D)

8. **Incorrect.** All promotions are processed through Departmental Promotional Committee after fulfilling all codal formalities.
9. As far as the judgement is concerned no such merit list is available at this office upon which the appellant has been appointed.
10. The office order dated 07.05.2024 was communicated to appellant through available sources well on time.


ON GROUNDS

- A. **Incorrect.** The impugned order dated 07.05.2024 communicated to appellant is legal, constitutional, lawful and of legal effect which was issued according to The Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.



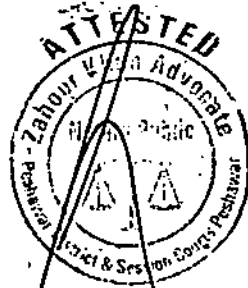

RECOMMENDATION:



2. Moreover the Seniority List had been issued fifteen years ago, however no objection was raised in this time period. Therefore, the appeal is rejected on the grounds of time barred".


