**CIVIL MISCELLANEOUS IN RESPECT TO  
RESTORE THE TITLED SERVICE APPEAL  
BEING DISMISSED ON THE BASIS OF NON-  
PROSECUTION VIDES ORDER DATED  
30.10.2024.**

*Respectfully Sheweth:*

1. The above titled case was scheduled for hearing on 30.10.2024. On this date, the counsel representing the appellant/applicant was unavoidably engaged before the Hon'ble Peshawar High Court, Abbottabad Bench, where multiple cases of the counsel were fixed for arguments before the Division Bench (D.B.). Consequently, the counsel could not attend the proceedings before this Hon'ble Tribunal when the appellant's case was called.
2. While the appellant/applicant and the counsel's clerk marked their appearance before this Hon'ble Tribunal, whilst the counsel had instructed the appellant to contact him promptly when the case was about to be called.

Unfortunately, the appellant briefly stepped out to use the restroom, and upon returning, he learned that the case had been dismissed on account of non-prosecution vide order dated 30.10.2024. **(Copy of the order dated 30.10.2024 is attached herewith)**


3. The absence of the counsel was entirely unintentional and unavoidable due to the professional commitment at the Peshawar High Court, Abbottabad Bench, which required his presence for arguments in several other cases. The appellant/applicant respectfully submits that the lack of representation was due to these explanatory circumstances and not due to any willful disregard for the proceedings of this Hon'ble Tribunal.
4. The appellant/applicant assures this Hon'ble Tribunal that utmost diligence will be exercised in future appearances, and every effort will be made to avoid any such occurrences.
5. That in fact, the subject petition includes valuable and fundamental right of the applicant and hence if the same is not restore, the applicant will suffer from an irreparable losses.
6. That there is no embargo to restore the same as the apex court via plethora of judgment observed that the matter has to be decided on the basis of merit rather on technicalities.
7. That any other ground may be raised at the time of arguments for the best assistance of this Honorable court.

In light of the above facts, the appellant/applicant humbly prays that this Hon'ble Tribunal may graciously be pleased to restore the titled case to its original position prior to the order of dismissal dated 30.10.2024.



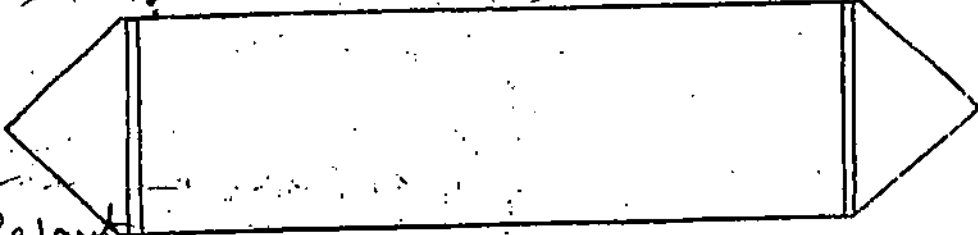
