1. That the subject cited above Service Appeal was fixed for hearing on **02.10.2024** before the August Khyber Pakhtunkhwa Service Tribunal Peshawar.
2. The August Court vide Order Sheet dated **02.10.2024** has directed the respondents department to produce the detail of officials who were sent for imparting in intermediate course and detail of seats reserved from **2018 to 26.03.2020** for Peshawar District
3. That the appellant was promoted to the rank of Head Constable in **17.01.2019**( Copy of his promotion is Annexed at Annexure-A)
4. That the appellant was nominated in a Criminal Case vide FIR No. **622**, dated **26.03.2020** u/s **324-34-302** PPC Police Station Chamkani District Peshawar. Therefore the appellant was placed under suspension. (Copy of FIR & Suspension order is Annexed at Annexure-B).
5. In the meanwhile a meeting regarding selection of official for the said Course was held on **28.06.2021**, wherein **36** officials were selected for the said course except the Appellant due to his involvement in the said Criminal Case as per annexed Minutes & Nomination for Intermediate Course at Annexure-C).
6. In the light of above mentioned meeting, **11** officials and **45** officials were selected for the said course on **23.12.2021** and **26.08.2022** respectively. Similarly, total **56** Nos officials were selected for intermediate course during the period of his retention in Jail.(Copy Annexed at Annexure- D).
7. On his releasing from the Jail in the said Criminal Case, he was re-instated in Service but couldn't select for imparting in Intermediate Course as he was overaged as per required age for the selection of Intermediate course in the light of Police Act, 2017 **48** years (Copy of re-instatement of appellant Annexed at Annexure-E)
8. On the basis of qualifying Intermediate Course, his **41** colleagues were promoted to the rank of ASI on **18.10.2022**. (Promotion copy Annexed at Annexure-F).
9. Later on, a **10** officials were selected for Intermediate Course in the year **2023**, but was held but he didn't discuss/consider being over aged. (Copy Annexed at Annexure-G).
