**JOINT PARA-WISE COMMENTS ON BEHALF OF RESPONDENTS NO. 1 & 2**

Respectfully Sheweth

**PRELIMINARY OBJECTIONS**

- i. That the appeal is not maintainable in its present form.
- ii. That the appellant has never challenged in time any order in which his right was ignored.
- iii. That the appeal is bad for mis-joinder and non-joinder of necessary parties.
- iv. That the appellant has no cause of action and locus stand to file the instant appeal.
- v. That the appellant has not come to the Tribunal with clean hands.
- vi. That the appeal is time barred.

**FACTS**

1. It is submitted that the appellant Engr. Muhammad Riaz Khan initially appointed as Assistant Engineer (BS-17) in irrigation Department, on the recommendation of Public Service Commission on 21.07.2007 (Annex-I). Later on he was appointed through Public Service Commission as Assistant Engineer / SDO in C&W Department on 04.01.2011 (Annex-II). On his arrival the appellant was exempted from practical training of 04 months and he was posted as SDO C&W Sub Division Ghiljo District Orakzai on 15.02.2011. The appellant subsequently promoted to the rank of Executive Engineer (BS-18) on 09.10.2019 (Annex-III).

7. Incorrect, the tentative seniority list of Assistant Engineers / SDOs (BS-17) were circulated on 17.04.2013 amongst the officers of department for objection if any within 15 days positively for rectification, whereby the appellant was placed at S.No.77 but despite lapse of specific period the appellant did not submit his objection and remained silent over the seniority list. Therefore, the department issued final seniority list on 01.01.2014 (Annex-IV) after approval of the competent authority, moreover the department fixed his seniority in light of merit assigned by Public Service Commission (Annex-V). Furthermore, final seniority list cannot be entertained for rectification. Therefore, the plea of the appellant is incorrect.
8. Incorrect, after rendering 13 years service at his credit, the appellant (Engr. Muhammad Riaz Khan) Executive Engineer (BS-18) forwarded an appeal / representation for re-fixing his seniority w.e.f 21.07.2007 instead of 04.01.2011 which was processed in the


department and filed the same on the basis that the appellant initially was appointed as Assistant Engineer (BS-17) in irrigation Department, on the recommendation of Public Service Commission on 21.07.2007. Later on he was appointed through Public Service Commission as Assistant Engineer / SDO (BS-17) in C&W Department on 04.01.2011, and subsequently promoted to the rank of Executive Engineer (BS-18) on 09.10.2019. Moreover, the appellant rendered more than 13 years' service in the capacity of Assistant Engineer (BS-17) and Executive Engineer (BS-18) in C&W Department. In fact, under section-8 (1) and (5) of Khyber Pakhtunkhwa Civil Servant Act 1973, the C&W Department notified final seniority list of AEs / SDOs (BS-17) with the approval of the Competent Authority (Chief Secretary KPK), every year, the appellant has not challenged then and at this belated stage, the officer has raised the issue of his seniority for the period rendered in the irrigation department. Beside this, the seniority of Engr. Muhammad Riaz Khan has been fixed as per merit list forwarded by the Khyber Pakhtunkhwa Public Service Commission.

### GROUNDS

- A. Incorrect and mis-conceived. All relevant rules have been followed and action taken is within the prescribed law as explained in para-8 of the facts. The appellant has not been wrongly placed rather fixed his seniority in light of his seniority assigned by Public Service Commission.
- B. Incorrect. There is no mala-fide intention of the respondents, no discrimination and no violation of rights of the appellant has been made. The respondents dealt the case strictly in accordance with law/regulation. Furthermore, Final seniority list is not challengeable under rules.
- C. Incorrect. No discrimination to any individual, including the appellant was made nor any rules or principal of law infringed. The apprehension of the appellant is mis-leading.
- D. Incorrect, as explained in para-8 of the facts. Proper procedure has been adopted during issuance of seniority list in view of prevalent rules/regulation.
- E. Pertains to record need no comments.
- F. Incorrect, seniority shall reckon according to the principal/procedure explained in Khyber Pakhtunkhwa Civil Servants Act, 1973.
- G. Incorrect. The Respondent No.1 as per law, merit and ESTACODE, the seniority of the appellant has been fixed as per Khyber Pakhtunkhwa Civil Servant Act, 1973.
- H. The respondents would like to seek permission of the Hon'able Tribunal to advance more grounds during the time of arguments.

In view of the above, it is humbly prayed that the instant appeal may kindly be dismissed with cost.


