

Respectfully Sheweth:

1. That the titled case was pending adjudication before this Hon'ble Tribunal, which was dismissed in default for non-prosecution vide order dated 12.11.2024. (Copy of the Order is attached).
2. That the case was fixed for 11.11.2024 for hearing, and when the counsel for the applicant/ appellant requested for adjournment it was highlighted that the case pertains to the year 2022 and cannot be adjourned. The counsel for appellant requested that the same may kindly be fixed in this month, however may not be fixed for 12.11.2024 and 13.11.2024 as on these two dates the counsel for appellant will be out of station in connection of other cases, and seeing genuine request of counsel, the same was adjourned. 3. That the said case was also not fixed in the cause list of 12.11.2024. (Copy of Cause List is attached)

5. That the absence/non-appearing of the counsel for the appellant, was neither deliberate nor willful, but due to the aforementioned reasons.
6. That valuable rights of appellant are involved in the matter, therefore, the same needs to be decided on merit.
7. That law favors adjudication on merits rather than technicalities.
8. That the application is well within time and there is no legal bar in acceptance of the instant application, rather the same is in the interest of justice as law favors adjudication of cases on merit rather than technicalities.

It is, therefore, prayed that by accepting this application, the titled case may please be restored to its original number and thereafter the same may please be decided on merits.

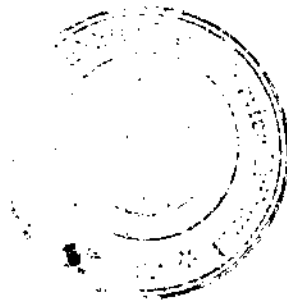

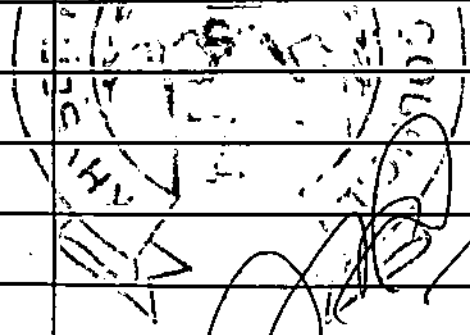
