APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 FOR ANTEDATING PROMOTION TO BPS-16 (SST) FROM THE DATE WHEN HE WAS NOT CONSIDER ON (11.10.2017) WITH ALL BACK AND CONSEQUENTIAL BENEFITS AND WHERE THE DEPARTMENTAL APPEAL OF THE APPELLANT WAS REJECTED WITHOUT SHOWING ANY LEGAL GROUNDS.

PRAYER:

THAT ON ACCEPTANCE OF THIS APPEAL THE REJECTION ORDER DATED 29.10.2024 MAY BE SET-ASIDE AND THE RESPONDENTS MAY VERY GRACIOUSLY BE DIRECTED TO CONSIDER THE APPELLANT FOR ANTEDATED PROMOTION TO BPS-16 W.E.FROM THE DATE OF NOT CONSIDERING HIM FOR PROMOTION AND WHEREAS HIS JUNIORS WERE PROMOTED TO BPS-16 ON (11.10.2017) BY MODIFY ORDER DATED 7.12.2020 WITH ALL BACK AND CONSEQUENTIAL BENEFITS. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF THE APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:

1. That the appellant had joined the Education Department on 30.11.2009 as PTC BPS-07. The appellant has been performing his duties upto the entire satisfaction of his superiors and never gave a chance of complaint to his high ups. The service record of the appellant is the evidence of his dedication and professionalism. **Copy of the appointment order is attached annexure-A .**
2. That a seniority list was issued in 2017 of the PTC teachers in which the appellant was placed at Sr. No. 583 in the seniority list while his junior of the appellant (Rafiq Ullah) was placed at serial number 596 of the same seniority list. **Copy of seniority list is attached as Annex-B.**
3. The DPC was convened on 11.10.2017 on the basis of above mentioned seniority list it is pertained to mention here that junior to the appellant was considered for promotion whereas appellant despite being eligible for promotion to the post of SST (BPS-16) but was not considered for the reason act known to the department. **Copy of DPC minutes of the meeting are attached as annexure-C .**
4. That later on when the appellant came to know above mentioned fact that he was not considered for the promotion at relevant time with out giving any reasons, the appellant filed an application on 3.4.2019 to the Director Education newly merged area FATA Secretariat Warsak Road Peshawar, but no fruitful action was taken by the competent authority on application of the appellant. **Copy of application is attached as annexure-D.**
5. That later on the appellant filed an application to the Provincial Ombudsman KP on 21.08.2019, regarding the discrimination in promotion. The ombudsman KP was kind enough to take cognizance of the application /Complaint of the appellant and gave its findings on 16/12/2019 as under:-

"It is established from the record that complainant promotion case was differed by DPC due to incomplete record and now the record is complete. The Agency not the complainant was in possession of the record, the fault cannot be attributed to him. Mal-administration is proved. It is recommended that complainant's case for promotion be considered within 30 days after receipt of

this forum subject to observance of all codal formalities under intimation to this forum".

Copy of application and reply are attached as Annex-E & E1

6. That later on DPC was held on 11.11.2019 and the appellant was promoted from PTC to SST BS-16 on 07.12.2020 with immediate effect. **Copy of minutes of meeting & notification dated 07.12.2020 is attached as Annex-F & F1.**
7. That an application of appellant was forwarded by the DEO (M) South Waziristan Tribal District at Tank on 27.02.2023 to Director E&SE for grant of seniority from the date of 11.10.2017 but no response by the worthy Director E&SE. **Copy of the application is attached as Annex-G.**
8. That the appellant again filed an application on 23.10.2023 to the Ombudsman Khyber Pakhtunkhwa regarding the grant of seniority/promotion from the date when the appellant was eligible for promotion but not so nominated. It is pertinent to mention here that the Ombudsman Khyber Pakhtunkhwa was kind enough to examine the application of the appellant and gave his finding on 06.11.2023 that, "*your complaint of falls outside the domain office this forum being service matter. As such we are constrained not to process at our end*". **Copy of application and reply to application are attached as Annex-H & I.**
9. That final seniority list was issued on 28.02.2024 and the junior to the appellant (Rafi Ullah S/o Abdul Aziz) placed above the appellant at Sr. No. 5121 while the appellant was placed at Sr. No. 10531 which is totally against the norms of justice. **Copy of final seniority list is attached as Annex-J.**
10. That when the above seniority list dated 28.02.2024 was communicated to the appellant, the appellant filed departmental appeal dated 11.07.2024 against the above mentioned seniority dated 28.02.2024 upon which the meeting of the committee was called vide order dated 07.08.2024 a meeting was convened on 16.08.2024 regarding the appellant seniority issue the committee recommendation that the applicant may be informed approach a proper forum for redressing his grievance the committee decision was not communicated to the appellant. **Copy of departmental appeal & minutes of the committee meeting are attached as Annex-K & K1.**

11. Therefore the appellant filed an application to Director E&SE, KP, Peshawar on 16.10.2024 to inform officially about the committee meeting decision, where upon the Assistant Director E&SE Khyber Pakhtunkhwa communicated the rejection order on 29.10.2024. Copy of application and rejection are attached as Annex-L & M.

12. That having no other remedy against the acts/omissions and rejection by the respondents, the appellant is constrained to come to this august Tribunal on the following grounds amongst the others.

GROUND:-

- A) That the inaction of the respondents and not considering the appellant for antedated promotion to BPS-16 w.e.f 11.10.2017 and the rejection order dated 29.10.2024 are against the law, facts, norms of justice, principles governing deferment cases. Therefore, such action/inaction of the respondents are not tenable under the law.
- B) That since the promotee has been deprived from his genuine right of promotion by illegal exercise of power of the respondent and such conducts of the government departments has been deprecated by the Supreme Court in judgment reported as 2009 PLC (C.S) P#40, 2008 PLC (C.S) 637, 2006 (PLJ) SC-1429 & 2013 PLC (C.S) 223.
- C) That appellant was not considered for promotion at the relevant time with out giving any reason which effect the right of appellant in a fanciful manner which is against the spirit of Article-2A, 4, 9, 25 & 38 of the Constitution.
- D) That the appellant being eligible candidate for promotion, and was not considered for promotion which is totally against the law, norms of justice and Superior Court Judgment wherein it has held that no one should be suffered for the fault of others.
- E) That the Honorable Supreme Court of Pakistan case reported as 2010 SCMR-1301 has held that in matter of promotion, rules are to be followed and where the discretion of authority is involved then that must be exercised with fairness. It is also held in the said judgment that promoting the juniors by ignoring seniors will not advance the object of achieving good governess. It is further pointed out in the said judgment that the Constitution is the Supreme Law and there is no room to allow the authority to make departure from law, rules and Article 4 and 25 of the Constitution but in case of appellant the above factum was ignored totally.


- F) That the august Supreme Court of Pakistan in a case reported as 2013 SCMR Page-1752 (d) has held that the term "Life" also includes reputation, status and all other ancillary privileges conferred on a citizens by law. Thus the decisions of not treating the appellant as per laid down principle without any just and fair reason is in violation of Article-9 of the Constitution of Pakistan because the conduct of the respondent affected the status and reputation of petitioner amongst the batch-mates and other service fellows.
- G) That even in latest Judgment of the Honorable Supreme Court of Pakistan reported as PLD 2013 (SC)-195. (Case of Anita Turab). It is held that the statutory provisions, rules regulations which Govern the matter of promotion of Civil Servants must be followed honestly scrupulously but the said principle was not followed in appellant case.
- H) That the appellant has been made to suffer for his belated promotion in an illegal and fanciful manner, which is not permissible in the eyes of law.
- I) That as per instructions, policy and law, in cases of deferment, the appellant is legally entitled to antedated promotion w.e.from 10.07.2017 alongwith seniority.
- J) That the appellant has not been dealt with in accordance with law rules and principles laid down by Superior Courts.
- K) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.



It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.





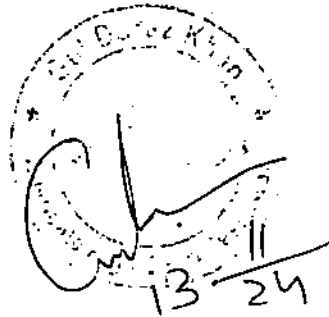

THE COMPLAINT

Muhammad Shoaib instituted complaint alleging that he was serving as PST since 30/04/2009 in Tribal merged District South Waziristan. He was eligible for promotion since 2016 and was recommended as Secondary School Teacher, (SST) (Maths & Physics), but was ignored and two junior PSTs namely Rafiqullah and Adnan Malik were promoted in 2017. He made an appeal against the decision before Director, Elementary & Secondary Education Khyber Pakhtunkhwa but received mute response. Complainant seeks redressal of his grievance through indulgence of this forum.

REPORT OF THE AGENCY

Notices under Section 10(4) of the Khyber Pakhtunkhwa, Provincial Ombudsman Act, 2010 were issued to Secretary, Elementary & Secondary Education Department Khyber Pakhtunkhwa Peshawar, Director (Education) Newly merged Tribal Districts, Warsak Road, Peshawar and District Education Officer (M), South Waziristan Tribal District at Tank. In response, District Education Officer (Male) South Waziristan Tribal District at Tank, submitted comments stating that the promotion of complainant was deferred at that time by Departmental Selection Committee on the basis of incomplete documents / entries relevant to promotion form PST to SST (Maths & Physics). Due to winter vacation, communication with him was impossible. Now, complainant has covered all shortcomings observed by the then DPC members and was trying to get the correct position in the promotion list.




FINDINGS:-

2. The DPC for promotion from PST to SST (M/P) was held on 21.07.2020 and he was promoted to the post of SST (M/P) vide Notification Endst: No.6523-31 Dated 07.12.2020.
3. As per finding of Provincial Ombudsman in complaint No.PO/Complaint /0737/08/2019 dated 16.12.2019 "he was deferred by Departmental Promotion Committee due to incomplete record". However, the record avails that he was not included in the working paper due to his low qualification mentioned in the Seniority list.
4. He has not submitted his appeal to the proper form.
5. He has submitted his appeal on 27.02.2023 which is time barred.


