



**APPEAL U/S 4 OF SERVICE TRIBUNAL ACT, 1974  
AGAINST NOTIFICATION NO. 3439 / EC-I DATED  
16-03-2021 WHEREBY COLLEAGUES OF APPELLANT  
WERE CONFIRMED FROM 16-04-2016 AND  
APPELLANT WAS IGNORED FOR NO REASON:**

**Respectfully Sheweth;**

1. That appellant was initially appointed / recruited as Probationer Assistant Sub-Inspector on 26-03-2011 and was then regularized after completion of the probation period. He was promoted to the rank of Officiating Sub-Inspector on 16-04-2014.
2. That on 12-10-2020, R. No. 01 circulated Seniority List of Officiating Sub Inspectors and Assistant Sub Inspectors with List "E" wherein name of appellant was figured at S. No. 72 along with his colleagues. (Copy as annex "A")

3. That regarding promotion, confirmation and anti-dation, DPC was constituted who examined the cases and held therein that it was principally agreed to grant favour to incumbents of their SHO period served during acting charge basis period and those PASIs of the batches who had completed their mandatory period, prior to amendment shall be confirmed on old criteria while those who could not complete periods prior of SHO, etc shall be confirmed as SI after completion of mandatory period (SHO etc). However on completion of the said period left over's PASIs shall be confirmed and they be assigned seniority with their batch-mates. (Copy as annex "B")
4. That prior to the said DPC / Notification, appellant has already completed his mandatory periods of SHO, etc. (Copy as annex "C")
5. That in pursuance of the decision of the said DPC, R. No. 01 issued Notification on 16-03-2021 wherein colleagues of appellant were confirmed in the rank of SIs with effect from the date, they completed mandatory period provided in PR 13.02 and Standing Orders issued from time to time, but appellant was ignored for no legal reason. (Copy as annex "D")
6. That in the year 2023, R. No. 01 circulated seniority list wherein appellant name was figured at S. No. 540 as SI with colleagues from S. No. 523 to S. No. 549. (Copy as annex "E")
7. That on 04-07-2024, R.No. 01 issued letter regarding confirmation of Sub-Inspectors. The name of appellant figures at S. No. 32. He had submitted the said ACRs well within time. (Copy as annex "F")
8. That on 11-07-2024, appellant submitted representation before R. No. 01 for confirmation in the rank of Sub-Inspector with his colleagues but in vain. (Copy as annex "G")
9. That on 02-09-2024, R. No. 01 issued subsequent Notification wherein colleagues of appellant were recommended for confirmation in the light of Departmental Selection Committee meeting held on

10-07-2024, while name of appellant was again dropped from recommendation. (Copy as annex "H")


10. That those colleagues of appellant who were left from confirmation with their colleagues filed appeals before this hon'ble Tribunal which came up for hearing on 10-10-2023 and then the hon'ble Tribunal was pleased to allow the same with direction to respondents to confirm them from the date when his other colleagues were confirmed as well as placed in due place in the seniority list. The appellants are also held entitled to all consequential benefits, if any. i.e. 16-04-2016 or as the case may be. (Copy as annex "I")

Hence this appeal, Inter Alia, on the following grounds:-

### **GROUND S**


- a. That appellant is serving the department with devotion and no complaint, whatsoever, was made against him in this respect.
- b. That appellant was deprived from confirmation as Sub Inspector for no reason.
- c. That colleagues of appellant were confirmed from 16-04-2016, while appellant was ignored, being similarly placed, for no legal reason.
- d. That no reason whatsoever was assigned to him for none confirming with colleagues and from the date when other juniors / colleagues were confirmed as per Notification dated 16-03-2021 being fully qualified and suitable for the same.
- e. That name of appellant was figured in the seniority list with his colleagues and then juniors were confirmed and he was left without assigning any reason.
- f. That in the circumstances, appellant is entitled to be confirmed as SI with his colleagues.

It is, therefore, most humbly prayed that on acceptance of the appeal, Notification dated 16-03-2021 be modified and appellant be confirmed as Sub-Inspector from the date when his colleagues are confirmed i.e. 16-04-2016 with all service / consequential benefits with such other relief as may be deemed proper.



## DEPARTMENTAL SELECTION COMMITTEE FOR PAFIS BATCH 2010-11

Departmental Selection Committee has been constituted in the backdrop of Writ Petition No. (Sic) in CM No. 2171/P filed by Abdul Sattar & others for their revised seniority and information in the rank of Sub Inspector after their names were brought on List E from the date confirmation in light of the judgment in Writ Petition No. 3720-P/2018. DSC had several directing on different dates and petitioners were also called in every meeting to hear their point of view. DSC comprised of the following officers:

1. SSP CO Ordination (Chairman)
2. SP HQ's
3. SP Security
4. SP Cantt Traffic
5. DSP legal
6. Office Supt

Petitioners were aggrieved of the following:-

- A. Their confirmation date in the rank of ASI shall be revised as DPC for both the batches was held late enough and if the same had been called on the due date i.e. after 03 years of completion of probation, they would have availed promotions chances and got eligibility in time for mandatory periods/courses.
- B. They should have been promoted as Offg SI in April 2014 when first DPC after the completion of their probation was held and petitioners be made senior to the promotees.
- C. They be confirmed on old criteria of SI confirmation which was applicable prior to 30.06.2018.
- D. Their nomination as per Form 13-15 Police Rules shall be sent to Central Police Office recommending their names to be included in List F from revised date.

Committee had threadbare discussion over the specific issue and relevant laws/rules were perused. Committee after mutual consultation agreed on the following recommendations:

1. As for as the grievance A of the petitioners regarding revision of their confirmation in the rank of ASI is concerned it appears to be based on valid reason. PR 12.08 states that directly recruited ASIs should be on probation for 03 years but in the present case of petitioners, the probation period exceeded by 03 years. The DPC date is required to be revised and they may be confirmed on completion of 03 years probation. PAFIS of batch 2011 were appointed on same date i.e. 26.03.2011 but PAFIS of batch 2010 were appointed on different dates, therefore their confirmation may be made from their dates of enrollment after completion of three years probation period.
2. As for as point B is concerned, after their confirmation in the rank of ASI is revised and comparing that date with that of the DPC for promotion of Offg SI held in April (sic)

Who were promoted through DPC held on 16.4.2014. Committee is of the opinion that petitioner's revised promotion shall be made from 16.4.2014 instead of 03.03.2017 & 12.02.2019.

3. After their revised promotion as Offg SI next question before committee was the confirmation of the petitioners in the rank of SI. As there are certain courses and mandatory periods prior to confirmation in the rank of SI as provided in PR

13.10 and some standing orders. PR 13.10 has been amended and a one year mandatory course has been introduced in 30.6.2018. Petitioners have been promoted on Acting Charge Basis on 24.07.2015 much prior to their regular promotion in the year 2017 and 2019. It was principally agreed to grant the favor to petitioners of their SHO period served during Acting charge basis period. Among these PASIs of 2010 and 2011 batches who had completed their mandatory period prior to the amendment in 30.06.2018 shall be confirmed on old criteria while those who could not complete mandatory periods prior to amendment in PR 13.10, they shall be confirmed as SI after they complete the mandatory period as provided in amended PR 13.10. However on completion of period and after confirmation these leftover PASIs shall be assigned seniority with their batch.

- 4. Amended PR 13.10(2) makes it mandatory for every SI to go through Upper College course before being confirmed in the rank. Petitioners were deputed for upper college course in year 2019 because their seniority was not properly adjusted. Now as their seniority is being revised and as per revised seniority they would have completed the subject course much earlier to the amendment, therefore committee is of the view that one time waiver may be granted to the batches of 2010-JI by not considering the date of completion of Upper College Course at the time of confirmation. This decision is being suggested specifically in the present circumstances and it may not be made precedent in future.

Police Department" (14) Service Appeal No. 7083/2021 titled "Muhammad Tahir Khan Vs. Police Department" and (15) Service Appeal No. 7596/2021 titled "Manzoor Khan Vs. Police Department" as in all these appeals common question of law and facts are involved.

3. Brief facts of the case, as given in the memorandum of appeal, are that appellants were initially appointed as Probationer Assistant Sub-Inspector in the year 2010-11. On 13.08.2014 services of the appellants were regularized with immediate effect instead from the date of their initial appointment i.e 26.03.2011. Appellant alongwith others filed writ petition No. 3720-P/2018, which was allowed vide judgment dated 24.04.2019. On 05.06.2020 respondent No.1 in pursuance of court order issued "E" list of seniority of the appellants with effect from the date of their initial appointment. On 01.07.2020 subsequent notification of colleagues of appellants was issued who were regularized from the date of their initial appointment. Appellant alongwith others were promoted to the rank of

Officiating Sub-Inspector w.e.f 16.04.2014. Vide notification dated

16.03.2021 appellants were confirmed in the rank S.I w.e.f 21.01.2021. Feeling aggrieved, he filed departmental appeal on 30.03.2021, which was not responded, hence the instant service appeal.

4. Respondents were put on notice who submitted written replies/comments on the appeal. We have heard the learned counsel for the appellant as well as the learned District Attorney and perused the case file with connected documents in detail.

5. Learned counsel for the appellant argued that appellants were not treated in accordance with law and rules. He contended that appellants were deprived from confirmation as S.I for the on the ground that he has not gone through the mandatory period of SHO etc. which objection is incorrect and illegal. He further contended that appellant is entitled to be confirmed as S.I from the date of promotion to the rank of officiating Sub Inspector i.e. 16. 04.2014. He submitted that notification dated 16.03.2021 is liable to be modified with effect from 16.04.2014 instead of with immediate effect.

6. Learned District Attorney contended that the appellants have contended that confirmation in the rank of S.I is subject to fulfillment of rule 13.10(2) and standing order issued by the provincial police officer from time to time; that the appellant was required to qualify the requisite criteria for confirmation in the rank of S.I. He further contended that appellants were confirmed S.I, when they fulfilled the mandatory requirement and orders are issued with immediate effect and not with retrospective effect as per law and rules. He added that colleagues of the appellant were promoted after fulfilling the requisite criteria.

7. Perusal of record reveals that appellant alongwith others were appointed as ASI in Police Department on 26.03.2011. Services of the

appellants were regularized on 13.08.2014 with immediate effect instead of from the date of initial appointment i.e 26.03.2011. Appellant filed writ petition for giving direction to respondents to regularize services appellant with effect from the date of initial appointment which was allowed and respondents issued notification to this effect on 05.06.2020 and name of the appellant was figured at Sr. No. 13 of list E but on 01.07.2020 services of the colleagues of the appellant were confirmed by ignoring appellant. On 12.10.2020 seniority list of officiating Sub-Inspector upon respondent of DSC by keeping his name at serial No. 39 it was decided in DPC that ASI who completed their SHO period during acting charge basis was given favour by confirmation and those who had not completed mandatory SHO period they will complete it and after completion they will be assigned seniority with their batch mates. As a consequence respondent No.1 issued notification of appellant's services confirmation with effect from 21.01.2021, the date upon which appellant completed mandatory training i.e 21.01.2021. Appellant was never recommended by respondents for mandatory training of SHO period, so he was deprived from confirmation along with his other colleagues on 16.04.2014. Record reveals that only reason for non confirmation of the appellant as S.I from 16.04.2014 like other colleagues was that appellant had not completed mandatory SHO period in accordance with Police Rules 13.10(2) of Police Rules, 1934, which is reproduced as under:

*"No Sub-Inspector shall be confirmed in substantial vacancy unless he has been tested for a year of an officiating Sub-Inspector in independent charge of a Police Station, a notified police post, or as In-charge Investigation of a police station or in counter terrorism."*

To this effect the worthy apex Court as well as this Tribunal, in numerous judgments have held that condition of posting as envisaged in the rule ibid.

us impediment in the way of confirmation as S.I was not attributable to the appellant because postings were beyond control of the appellants, which powers rests with the competent authority and subordinate officials cannot be punished for such administrative lapses on part of the relevant authority, hence depriving him from being confirmed in the rank of SI alongwith batch mates would tantamount to his deprivation from further progression, which was not justified. It was also noted that respondents totally ignored Rules 13.18 of Police Rules, 1934, wherein it is laid down that all police officers promoted in rank shall be on probation for two years, provided that the appointing authority may, by a special order in each case, permit periods of officiating service to count towards a period of probation. On the conclusion of probation period a report shall be rendered to the authority empowered to confirm the promotion who shall confirm the officer or revert him.

8. In view of the forgoing discussion, we are of the considered opinion that case of the appellant is similar in nature with the cases already decided by this Tribunal as well as by the apex court, as referred to by counsel of the appellants. For the reasons, we are inclined to accept the present appeal with directions to the respondents to confirm the appellants as SI from the date when his other colleagues were confirmed, as well as place him in due place in the seniority list. The appellants are also held entitled to all consequential benefits, if any. Costs shall follow the event. Consist:
