
Respectfully Sheweth;

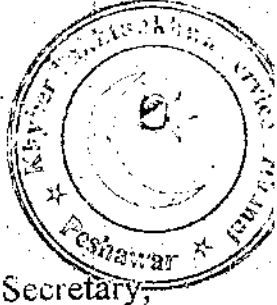
