

promoted to the post of Instructor Grade-I
(B-15) as per his entitlement.

ii. It is also prayed that the respondents be restrained from proceeding/promotions to the post of Instructor Grade-I BPS-15, till the final decision of the instant departmental appeal.

The facts of the instant appeal are as under:

FACTS

- That initially appellant was appointed as Naib Qasid on 27.01.2010 in respondent Department on contract basis and later on in year 2012 he amongst others was regularized.
- 2. That the appellant was promoted to the post of Instructor Grade-III BPS-8 on 23.05.2017 and due to his seniority/entitlement he was further promoted to



the Instructor Grade-II BPS-12 vide dated 14.12.2020. (Copies of all relevant documents are attached)

That the respondent, prepared a seniority list on 27.01.2022, wherein appellant was placed at Serial No.16 of the Seniority list, and was hopeful qua his promotion, but he got astonished to know that the respondent malafidely issued another seniority list on 29.04.2022 wherein he was allegedly figured at Serial. No.57 (Copies of both seniority lists are attached as annexure-A & B Respectively).

4. That all those colleagues who were appointed as class-iv mentioned as under,

So, as per seniority the appellant is most senior but the respondent just on malafide intention placed him at Serial No. 57, hence such act of respondent is highly discriminatory, void ab inito, hence liable to be struck down.

That the official respondent concealed the subsequent seniority list and the appellant was apprised by one of his colleagues on 09.05.2022 that the respondent has prepared a seniority list where his junior most colleagues have been benefited, so the appellant received the same and intended to file the instant appeal just for the rectification his seniority position.

against by violating the rules, law and policy and any promotion on the strength of such allege seniority list would be no value in eyes of law, hence this worthy office having ample power, under the mandate of law to rectify the same, and restore the actual seniority position of appellant as per his entitlement.

and as per law the seniority would be reckoned from the date of initial appointment and thereafter the promotion would be made on the basis of seniority, as evident from the table mentioned *ibid*, the appellant is most senior but he was malafidely deprived from his legal right.

It is therefore humbly prayed that on acceptance of the instant departmental appeal, the position of appellant may kindly be retained at serial No.16 of the seniority list and in pursuance of such position i.e. at

Serial No.16, he be promoted to the post of Instructor Grade-I (B-15) as per his entitlement.

ii. It is also prayed that the respondents be restrained from proceeding/promotions to the post of Instructor Grade-I BPS-15, till the final decision of the instant departmental appeal.
