RESPECTFULLY SHEYWETH: PRELIMINARY OBJECTIONS:

- That the Respondent No. 4 namely Rizwan UI Haq was recommended to the
 Government for appointment in compliance of order dated 24.08.2022.
 Appeal is not entertainable.
- That the appellant has got no locus standi or cause of action against the replying respondent.
- 3. That the appellant has not approached this Honorable Tribunal with clean hands.
- 4. That no discrimination / injustice has been done to the appellant.
- 5. That the appeal is not based on facts and is unjustified and illegal demand against the lawful authority of the Commission.
- That the appellant has been treated in accordance with law and rules.

ON FACTS:

- 1. Pertains to record / proof / personal information of the appellant. Needs no comments.
- 2-3. That the Khyber Pakhtunkhwa Public Service Commission advertised ninety one (91) posts of Male Lecturer (Physics) vide Advertisement No 06/2021 Serial No. 1 with the following qualification: -

The appellant, amongst other candidates, applied for the said posts. They were called for screening test and interview. The appellant secured merit order No. 92 (Merit list Annex-B). He was coming in the orbit of selection, therefore, was recommended to the Government for appointment (Recommendation Annex-C).

- 4. Does not pertain to Khyber Pakhtunkhwa Public Service Commission.
- 5-7. That in the meanwhile, the respondent No. 4, Mr. Rizwan ul Haq filed a representation to the Commission for award of distinction mark (Annex-D) which was declined by the Commission being devoid of merit (Annex-E). Feeling aggrieved he filed Writ Petition No. 1918-P/2022 in the Peshawar High Court Peshawar and the same was allowed vide order dated 24.08.2022 in the following terms:

6. This appeal is admitted and allowed with the directions to the respondents to grant one distinction mark to the appellant in accordance with marking criteria and reconsider his merit position by placing him amongst the candidates figured at serial No. 44 to 66 as per merit policy and recommend him for appointment against the post of Male Lecturer Physics (BPS-17), if he otherwise eligible."

(Annex-F)

Thereafter, the Commission forwarded the judgment to the Law Department for examining the same as to whether Civil Petition for Leave to Appeal may be filed or otherwise. However, after threadbare discussion it was declared an unfit case for filing of Civil Petition for Leave to Appeal (Annex-G). Consequently, the Commission in compliance of the order dated 24.08.2022, revised the

recommendation list by awarding one (01) mark of distinction to Respondent No. 4 (Revised Recommendation List Annex-H). Hence, respondent No. 4 being on better merit position as compared to the appellant was recommended to Government for appointment, whereas the name of the appellant was withdrawn. Thus, the appellant's appointment / recommendation was revised purely by the application of due process of Law and orders of Honorable Peshawar High Court. Moreover, Appellant earlier Writ Petition No. 1412-M/2023 on the same issue has already been ordered as dismissed as withdrawn (Annex-I).

As far as the Khyber Pakhtunkhwa Public Service Commission is concerned, the recommendation of the appellant was withdrawn (Annex-J) in compliance with the order of the Honorable Peshawar High Court. Thus, the appellant being not aggrieved person from any act of the replying respondent may not be allowed to raise further grounds to save the precious time of this Honorable Tribunal.

GROUNDS:

- **a.** Pertains to personal information of the appellant.
- **b-d.** As explained in preceding paras, the replying respondent has acted in compliance of order dated 24.08.2022 of the Peshawar High Court.
- e. Does not pertain to replying respondent.
- f-g. Incorrect. As explained in preceding paras.

It is, therefore, humbly prayed that on acceptance of the submissions made herein above, the instant appeal may please be dismissed having no legal footings.



Since the petitioner has got 1st position in order of merit in the University, hence he is entitled for one distinction marks as per Par-VII of Marking System for posts filled by other than syllabus based competitive examination. At the time of submission of documents on first time and before conducting the interview held on 7.2.2022, the petitioner had supplied all the documents including BS Physics certificate original BS (4 years) in Physics certificate issued by the University of Malakand to the respondents, but in the tentative recommendations list prepared by the respondents, the one distinction mark was not awarded to the petitioner, on the ie EXAMINER Postiower High Court unfounded and frivolous ground of non mentioning the aforesaid original certificate in the initial application,

the respondents have refuted the claim of the petitioner on the sole ground that the petitioner could not produce the BS certificate before calculation of total marks for preparation of general merit list. But record divulge that alongwith the comments the respondents have placed the certificate of BS Physics duly issued by the University of Malakand on 3.11.2021, whereas the interview of petitioner has been conducted on 7.2.2022, wherein he has produced the original certificate before the interview committee it is manifest from record that the petitioner has disclosed the factum of BS Physics with distinction. The learned AAG alongwith representative when confronted with the online application wherein information about first division has been provided, they could not wriggle out of the situation and remained tightlipped. It is established from the record that the petitioner was entitled for one additional mark on account of his first position in BS Physics, but the same was not awarded during calculation of total marks for preparation of merit list. On awarding of one distinction marks the petitioner will get a place amongst the candidates having 68 marks shown in the merit list from serial No. 44 to 60 of the general merit list as such was eligible to be recommended for the post of male Lecturer

MINUTES OF THE SCRUTINY COMMITTEE MEETING.

(AGENDA ITEM NO. 03)

SUBJECT:

PETITION NO. 1918-P/2022 RIZWAN UL HAO VERSUS KHYBER PAKHTUNKHWA PUBLIC SERVICE COMMISSION.

A meeting of the Scrutiny Committee was held on 21-09-2022 at 11:00 A.M. in the Conference room of Law, Parliamentary Affairs & Human Rights Department under the Chairmanship of Secretary Law to determine the fitness of the subject case for filing of Appeal/CPLA before the Supreme Court of Pakistan. Advocate-on-Record (Mr. Mohi-ud-Din Humayun) represented the Advocate General office, Kliyber Pakhtunkhwa.

The representatives of Khyber Pakhtunkhwa, Public Service Commission (Mr. Hamid Saleem, Law Officer) alongwith (Shahid Iqbal, Litigation Assistant) apprised the Committee about the background of the case and stated that the Petitioner Rizwan-Ul-Haq (candidate for the post of Lecturer in Physics) filed the subject Writ Petition with the prayer to direct to respondents to award one distinction mark to the petitioner as per rules. The Hon'able Peshawar High Court, Peshawar vide its Judgment dated 24.08.2022 allowed the subject writ petition with direction to the respondents to grant one distinction mark to the petitioner in accordance with marking criteria and to reconsider his merit position by placing him amongst the candidates figured at serial No.44 to 60 as per merit policy and recommend him for appointment against the post of Male Lecturer Physics (BPS-17), if he otherwise eligible. The Scrutiny Committee examined the case in depth and decided that the subject case was not a fit case on the following grounds:

GROUNDS/DISCUSSIONS:

- The record transpired that the petitioner had qualified BS Physics examination i. with distinction, however, distinction mark were not awarded to the petitioner by the Public Service Commission. The Scrutiny Committee perused Part-VII of Klyber Pakhtunkhwa Public Service Commission Regulation, 2003 which allowed distinction marks for standing first in University. Perusal of the record further transpired that the respondents did not deny the first position of the petitioner from the department of Physics University of Malakand, however the stance of the department was that the petitioner did not substantiate his claim in the application through cogent documentary proof and it was not denied by the department that the distinction certificate was not produced by the petitionerbefore the interview panel on 07-02-2022.
- The Scrutiny Committee held that it was established from the record-that the ij. petitioner has got first position in order of merit in the University and was entitled for the additional marks on account of his first position in BS Physics which fact has also not been denied by the department. The Scrutiny Committee further held that not awarding distinction marks during calculation of total marks for preparation of merit list was not based on legal footing, therefore, it would not be advisable to file CPLA against the impugned judgment.

Hence in view of above, it was decided with consensus by the Scrutiny Committee that the subject case was not a fit case for filing of Appeal/CPLA in the Supreme Court of Pakistan.
