Education Department has also dragged a structure of rules/qualification for promotion to the post of Senior Arabic Teacher. The appellant has relied upon the rules issued vide Notification dated 13.11.2012 wherein, the department has pointed out the criteria for promotion to Senior Arabic Teacher as under:

"By promotion, on the basis of seniority-cum-fitness, from amongst Arabic Teachers, with at least five years service as such and having qualification as prescribed for initial recruitment of Arabic Teacher."

6. The above rules have been annexed by the appellant in the appeal. While on the other hand, plea of the respondents is that the said rules have been amended vide Notification dated 30.01.2018 wherein, the qualification criteria for promotion to the post of Senior Arabic Teacher has been enhanced as:

"At least Second Class Master Degree in Arabic OR at least Second Class Bachelor Degree from a recognized University with Shahadatul Alamia Fil Uloomul Arabia Wal Islamia, from a recognized Tanzimuatul Wafaqul Madaris"

7. Admittedly, the teacher namely Nabeela Anum, junior to appellant was promoted to the post of Senior Arabic Teacher, which promotion was objected by the appellant, but she (Nabeela Anum) had the qualification of Master Degree while appellant has no such degree, either Master or Bachelor, therefore, was not promoted.

A Constitution of the cons

the appellant was left at her own position of Arabic Teacher in BPS-15; that feeling aggrieved, she filed departmental appeal but the same was not responded, hence, the instant service appeal.

- 2. On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellant.
- 3. We have heard learned counsel for the appellant and learned Assistant Advocate General for respondents.
- 4. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Assistant Advocate General controverted the same by supporting the impugned order(s).
- S. Record reflects that she was appointed on 09.05.2013 and was performing her duties in the said capacity. In order to learn about her seniority position, she made written request on 24.08.2022 for provision of seniority list. In response, seniority list was provided by the respondents, wherein, Arabic Teachers appointed later than her appointment, were granted promotions to the post of Senior Arabic Teacher (BPS-16) and the appellant was not. The case in hand shows that appellant was discriminated, however, for promotion or appointment to a post, the departments frame rules for the purpose, hence the
