order and medical fitness certificate were signed by a single authority, therefore, genuineness appointment is doubtful.

6. The appointment of appellant has not been denied by the respondents in their reply. When the appointment order is not denied, the contentions that his appointment was doubtful or both the documents (appointment and medical certificate) signed by the same authority do not carry weight. Even if the appointment order was illegal, so why the respondents were hesitating to proceed against the appellant departmentally. But if he has served, he has to be paid for his service.

7. In view of above, instant service appeal is allowed and the respondents are directed to release his salaries from the date of his appointment and let him serve satisfactorily. Costs shall follow the event. Consign.

2. On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellant.

3. We have heard learned counsel for the appellant and learned District Attorney for respondents.

4. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned District controverted the same by supporting the impugned order(s).

5. Perusal of record shows that appellant was appointed vide order dated 30.10.2019 by the order of the then Agency Surgeon, Khyber District at Jamrud. However, salary was not given to him for the reason that he was illegally appointed. **KALIM ARSHAD KHAN, CHAIRMAN:** Brief facts of the case, as per averments of the appeal, are that the respondents had advertised the post of Chowkidar on 13.04.2019 in response of which, appellant applied on 15.04.2019; that after fulfillment
