APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER DATED 13.12.2017 WHEREBY THE APPELLANT HAS BEEN AWARDED PROMOTION TO THE POST OF SCT (BPS-16) WITH IMMEDIATE EFFECT RATHER THAN RETROSPECTIVE EFFECT i.e. 26.04.2016 AND FOR THE GRANT OF CORRECT SENIORITY POSITION ACCORDING TO THE SENIORITY LIST ISSUED ON 11.02.2019 AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

That on acceptance of this appeal the impugned order dated 13.12.2017 may very kindly be modified/rectified to the extent of promotion of the appellant to the post of SCT (BPS-16) w.e.f 26.04.2016 instead of 13.12.2017 with all back benefits. The respondents may further please be directed to enlist the name of appellant on her correct seniority position below the name of Mst: Ramim Begum as per seniority list issued on 11.02.2019. Any other relief which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

Briefs facts of the present appeal are as under:-

- 1- That the appellant was initially inducted in the respondent Department as CT (BPS-09 now BPS-15) vide order dated 06.08.1995. That after appointment the appellant started performing her duty at GGMS Sadiq Abad, Bajaur Agency quite efficiently and upto the entire satisfaction of her superiors. Copy of the appointment order is attached as annexure.....A.

- 2- That during service the appellant was transferred from Bajaur Agency to GGMS Nabi, Distric Swabi vide order dated 18.04.2003 and since then the appellant is performing her duty at District Swabi with full devotion and honesty. Copy of the order dated 18.04.2003 is attached as annexure.....**B.**
- 3- That the appellant while performing her duty as CT (BPS-15) many colleagues and junior colleagues of the appellant were promoted to the post of SCT (BPS-16) vide order dated 26.04.2016 and subsequently they were adjusted against the schools noted in the adjustment order dated 28.04.2016 while the appellant has been ignored from the said promotion to the post of SCT (BPS-16) without any reason and clear justification. Copies of the adjustment order dated 24.04.2016 is attached as annexure.....**C.**
- 4- That it is pertinent to mention that the appellant was later on promoted to the post of SCT (BPS-16) vide order dated 13.12.2017 with immediate effect rather than retrospective effect i.e. w.e.f. 26.04.2016 when colleagues and junior colleagues of the appellant were promoted. That after appointment the appellant was adjusted at GGHSS Marghuz, Swabi vide adjustment order dated 25.01.2018 and the appellant properly started performing her duty at the station concerned with all zeal and zest. Copy of the adjustment order dated 25.01.2018 is attached as annexure.....**D.**
- 5- That it is also pertinent to mention here that the respondent department circulated seniority list on 11.02.2019 whereby name of the appellant stood at serial No.31 below the name of Mst; Ramim Begum. That recently it came into the knowledge of appellant that the seniority position from serial No.31 has been disturbed in the seniority list circulated in 2021. That the appellant time and again requested the authority concerned for delivering the copy of seniority list of 2021 but authority is not willing to deliver the same. Copy of the seniority list is attached as annexure.....**E.**
- 6- That the appellant feeling aggrieved from the impugned order dated 13.12.2017 and from disturbing the seniority position of the appellant, preferred departmental appeal before the respondent No.2 but no reply has been received so far. That it is also pertinent to mention that during pendency of the departmental appeal of the appellant the respondent department circulated tentative seniority list for the year 2022 vide dated 10.01.2022 whereby the name of appellant stood at serial No. 136 while correct position of the appellant is serial No.31 below the name of Mst; Ramim Begum, SCT (BPS-16). Copies of the departmental appeal & seniority list are attached as annexure.....**F & G.**
- 7- That the appellant feeling aggrieved and having no other remedy but to file the instant service appeal on the following grounds amongst the others.

• GROUND:

- A- That the impugned order dated 13.12.2017 and seniority list issued on 10.01.2022 are against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be rectified/modified to the extent of appellant.
- B- That the appellant has not been treated by the respondent department in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That the respondent department acted in arbitrary and malafide manner while promoting the appellant w.e.f 13.12.2017 instead of 26.04.2016 and disturbing the seniority position of the appellant from serial No.31.
- D- That by not promoting the appellant to the post of SCT (BPS-16) with retrospective date i.e. 26.04.2016 is the violation of principle of natural justice.
- E- That the respondents acted in arbitrary and malafide manner by not allowing/ granting promotion to appellant to the post of SCT (BPS-16) with retrospective date despite the fact that the appellant is the senior most employee of the respondent Department and is fully entitled for promotion to the post of SCTT (BPS-16) on the basis of seniority-cum-fitness.
- F- That the inaction of the respondents by not allowing/granting promotion w.e.f. 26.04.2016 to the appellant to the post of SCT (BPS-16) is violative of Section-9 of the Civil Servant Act 1973 read with Rule-7 of the (Appointment, Promotion & Transfer) Rules 1989.
- G- That as per Rules and regulations the appellant is fully entitled for pro-forma promotion to the post of SCT (BPS-16) with all consequential benefits.
- H- That the respondent department denied promotion of the appellant to the post of SCT (BPS-16) in the 2016 when colleagues and junior colleagues were promoted while the appellant has been promoted on 13.12.2017 which caused to affect the seniority of the appellant, therefore, this act of the respondents is against the law and rules *ibid*.
- I- That the act of the respondent department by disturbing seniority position of the appellant is violative of Section-8 of the Civil Servant Act, 1973 read with Rule-17 of the appointment, Promotion & Transfer Rules, 1989.
- J- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.
