1. That the appellant was performing their duties in Orakzai Agency on different posts.
2. That on 13.10.2017 the respondent No.4 issued a promotion order of different SST's. (Copies of promotion order dated 13.10.2017 is attached as annexure "A")
3. That Khyber Pakhtunkhwa Government have already issued a promotion order of different post to the SST on 31.10.2014. (Copy of the Notification dated 31.10.2014 is attached as annexure "B").

4. That as seniority of list of Education Department of Khyber Pakhtunkhwa Government and persons performing their duties in FATA Education Department are prepared jointly.
5. That appellant after the issuance of the promotion order /notification dated 13.10.2017, submitted a application/representation to respondent No.4. (Copy of Representation is attached as annexure C).
6. That after a laps of considerable time no response from respondents concerned appellants are constrained to approaches this Hon'ble Tribunal on the following amongst other grounds:-

G R O U N D S:

- A. That the impugned promotion notification dated 13.10.2017 is against facts, if law and rule, therefore liable to be set aside.
- B. That valuable rights of the appellant in shape of have been violated because of the issuance of the promotion to SST at such belated stage.
- C. That due to late issuance of promotion order dated 31.10.2017, valuable rights in shape of seniority

have been violated which is to be reckon from the issuance of date of promotion of the Government of Khyber Pakhtunkhwa dated 31.10.2014.

- D. That the appellant have not been treated according to law and promotion policy.
- E. That the appellants have been condemned unheard and not been treated according to law and policy.
- F. That the appellant have been condemned unheard and not been treated according to law and policy.
- G. That according to the articles No.4 to 25 every citizens are to be treated equally while in the case of appellant, they had not been treated equally needs interference.
- H. That through this promotion order at a such belated stage speaks discrimination which s against natural justice, equity and law.
- I. That any other grounds will be raised at the time of arguments with the permission of this Hon'ble Court.

It is, therefore most humbly prayed that on acceptance of this appeal, this Hon'ble Tribunal order the promotion notification dated 31.10.2014 shall be deemed and issue on.

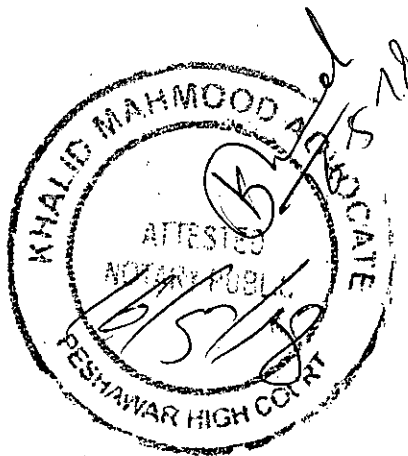

- That the Appeal is not maintainable in the present form being devoid of merits.
- That the conduct of Appellant estopped him to bring the instant appeal.

ON FACTS.

law/policy which is always be granted with immediate effect, **policy of promotion attached as (Annex-B).**

6. The respondents also submit inter alia on the following grounds.

Grounds:

- A. Incorrect. Appellant is under confusion as there is difference between up-gradation of post and promotion, as far as up gradation is concerned which has been carried out vide notification dated 8-8-2016 and has been given retrospective effect w.e.f 1-7-2012 and teachers in erstwhile FATA are getting remunerations accordingly against the upgraded posts, whereas notification dated 13-10-2017 pertained to promotion, which clearly and expressly reflects constitution of departmental promotion committee, moreover under the **Khyber Pakhtunkhwa Civil Servants Promotion Policy, 2009** promotion will always be notified with immediate, therefore, the appellant has no legal cause of action/ grievance and the instant appeal liable to be dismissed. **(notification attached as Annex-A & policy of promotion attached as Annex-B)**
- B. Incorrect. Promotion is subject to rules/policy. More over Policy is prerogative of the Government and respondent department is bound to follow the policy in vogue.
- C. Incorrect hence denied. As replied above.
- D. Incorrect. Promotion is subject to rules/policy, the respondents are bound to abide the policy / rules.
- E. Incorrect hence denied. The appellant has been treated as per policy and rules.
- F. Incorrect hence denied. The appellant has been treated as per policy and rules.
- G. Incorrect. Promotion is subject to rules/policy. More over Policy is prerogative of the Government and respondent department is bound to

follow the policy in vogue, the appellant has been treated as per policy and rules.

- H. Incorrect. No discrimination made to the appellants.
- I. The respondent seeks leave to raise additional ground at the time of arguments.





Promotion Policy

In order to consolidate the existing Promotion Policy, which is embodied in several circular letters issued in piecemeal from time to time, and to facilitate the line departments at every level in prompt processing of promotion cases of Provincial civil servants, it has been decided to issue the "Khyber Pakhtunkhwa Civil Servants Promotion Policy, 2009" duly approved by the competent authority, for information and compliance by all concerned. This Policy will apply to promotions of all civil servants holding appointment on regular basis and will come into effect immediately. The Policy consists of the provisions given hereunder:-

I. Length of service.

(a) Minimum length of service for promotion to posts in various basic scales will be as under:

Basic Scale 18 :	5 years' service in BS-17
Basic Scale 19:	12 years' service in BS-17 & above
Basic Scale 20:	17 years' service in BS-17 & above

No proposal for promotion shall be entertained unless the condition of the prescribed length of service is fulfilled.

(b) Service in the lower pay scales for promotion to BP-18 shall be counted as follows:

- (i) Half of the service in BS-16 and one fourth in Basic Scales lower than 16, if any, shall be counted as service in Basic Scale 17.
- (ii) Where initial recruitment takes place in Basic Scale 18 and 19, the length of service prescribed for promotion to higher Basic Scales shall be reduced as indicated below:

Basic Scale 19	7 years' service in BS-18
Basic Scale 20	10 years' service in BS-18 & above, or 3 years' service in BS-19.

II. LINKING OF PROMOTION WITH TRAINING:

(a) Successful completion of the following trainings is mandatory for promotions of officers of the Provincial Civil Service / Provincial Management Service to various Basic Scales:

- Mid-Career Management Course at National Institute of Management (NIM) for promotion to BS-19
- Senior Management Course at National Management College, Lahore for promotion to BS-20
- National Management Course at National Management College, Lahore for promotion to BS-21

(b) This condition will not be applicable to civil servants in specialized cadres such as Doctors, Teachers, Professors, Research Scientists and incumbents of purely technical posts for promotion within their own line of specialization as envisaged in the existing Promotion Policy. However, for promotion against technical posts in BPS-20, which require Managerial and administrative skills, the SMC shall be mandatory. Substituted vide No. SO(Policy)/E & AD/I-16/2017 dated 05-12-2017

inadvertent omission for promotion comes to notice, is considered by the Provincial Selection Board/ Departmental Promotion Committee and is declared fit for promotion to the next higher basic scale, he shall be deemed to have been cleared for promotion along with the officers junior to him who were considered in the earlier meeting of the Provincial Selection Board/Departmental Promotion Committee. Such an officer, on his promotion will be allowed seniority in accordance with the proviso of sub-section (4) of Section 8 of the Khyber Pakhtunkhwa Civil Servants Act, 1973, whereby officers selected for promotion to a higher post in one batch on their promotion to the higher post are allowed to retain their inter-se-seniority in the lower post. In case, however, the date of continuous appointment of two or more officers in the lower post/grade is the same and there is no specific rule whereby their inter-se-seniority in the lower grade can be determined, the officer older in age shall be treated senior.

- (c) If a civil servant is superseded he shall not be considered for promotion until he earns one PER for the ensuing one full year.
- (f) If a civil servant is recommended for promotion to the higher basic scale/post by the PSB/DPC and the recommendations are not approved by the competent authority within a period of six months from such recommendations, they would lapse. The case of such civil servant would require placement before the PSB/DPC afresh.

✓ VI. DATE OF PROMOTION:

Promotion will always be notified with immediate effect.

VII. NOTIONAL PROMOTION:

In respect of civil servants who retire (or expire) after recommendation of their promotion by the PSB/DPC, but before its approval by the competent authority, their promotion shall be deemed to have taken effect from the date of recommendation of the PSB/DPC, as the case may be, and their pension shall be calculated as per pay which they would have received had they not retired/expired.

VIII. PROMOTION OF CIVIL SERVANTS WHO ARE AWARDED MINOR PENALTIES.

- (a) The question of promotion to BS-18 and above in case of civil servants who have been awarded minor penalties has been settled by the adoption of quantification of PERs and CEI which allows consideration of such cases for promotion subject to deduction of 5 marks for each major penalty, 3 marks for each minor penalty and 1 mark for each adverse PER from the quantified score and recommendation for promotion on attaining the relevant qualifying threshold.
- (b) However, the CEI policy is not applicable to civil servants in BS-16 and below. In this case, the concerned assessing authorities will take into consideration the entire service record with weightage to be given for recent reports and any minor penalty will not be a bar to promotion of such a civil servant.

IX. PROMOTION IN CASE OF PENDING INVESTIGATIONS BY NAB:

If there are any NAB investigations being conducted against an officer, the fact of such investigations needs to be placed before the relevant promotion fora which may take a considered decision on merits of the case.
